# South Portland Teen Center at Redbank Community Center 2018-2019 School year

The Teen Center is a facility for Middle School and High School Students (grades 6-12) who live in South Portland and/or attend school in South Portland. All students who want to have access to the Teen Center must fill out this packet and have all sections signed by a parent/guardian. The South Portland Teen Center's mission is to provide a comfortable, safe and fun environment for teens. As such, each teen is held responsible for their behavior, where people and property are the first priority. Respect for the Redbank Community Center facility, other teen participants and program staff/volunteers is required of everyone.

#### **Our Objective:**

To provide Middle School and High School aged students with a fun, safe place to spend their after school hours in an environment that is free of violence and intimidation, encouraging the development of social and emotional growth among its teen members.

#### **Code of Conduct**

## Participant and a Parent/Guardian must read, sign and return this packet prior to participating at the South Portland Teen Center.

At the South Portland Teen Center, we strongly believe in the development of all participants. Whether it is through team-building activities, educational field-trips, simple dialogue, friendly competition, or just hanging out with peers; one of our goals remains constant, which is, to see our participants be positively involved within the community around them. In order to promote safety and responsibility, we ask that all South Portland Teen Center participants read and sign the following Code of Conduct, which includes:

- 1. Physical contact with another person in an aggressive or threatening manner. This includes, but is not limited to, Teen Center Staff, Redbank Staff, Park and Recreation Employees, patrons of the facility, and other student's/peer participants.
- 2. Theft or behavior that results in the destruction of property of others. This includes not showing respect for the property within the Redbank Gym and around the facility (i.e. littering after eating). Note: Any equipment deliberately broken by an individual will be paid for by that individual at replacement cost. The South Portland Teen Center is not responsible for any lost or stolen items. We recommend that participants avoid bringing valuable items such as MP3 players, cell phones and other personal electronics, as well as large amounts of cash.
- 3. Carrying or concealing any weapons, devices, or objects that are intended to be used as a weapon or appear to be a weapon.
- **4.** Possessing, selling, and/or using illegal substances, tobacco or alcohol products, or any other drug paraphernalia or coming to the Teen Center under the influence of such substances. Smoking on or around the Redbank Gym and Teen Center facility (parking lots, park area, etc.).
- 5. Harassment, bullying and/or intimidation by words, gestures, body language, etc. Disrespect of self, other, or staff. All participants of the Teen Center shall show respect towards all people within the Teen Center and throughout the facility.
- **6.** Any demonstration of sexual activity or sexual contact with another person.
- 7. Offensive or vulgar language and the use of profanity. This includes the lyrics of songs, when participants use speakers to listen to music.
- **8.** Unacceptable attire: clothing that is too revealing; advertises drugs, alcohol, has obscenities or vulgarity on it. Displays symbols, pictures or words which in any way are determined to be in conflict with Teen Center's expectations.
- 9. All individuals must leave the building at the scheduled closing time, unless you are *immediately* going to another supervised activity within the building, such as basketball practice. If you do not leave at the scheduled closing time you will lose the right to use the facility.
- 10. Students must sign in upon arrival, and sign out when leaving. Students may not leave the teen center or building and return in the same day.
- 11. Use of the facility and this program is for South Portland residents **ONLY**.

12. Participants must have a completed Code of Conduct packet on file, signed by a parent or guardian before using teen center. Code of Conduct packets will need to be completed each year, at the start of school, to ensure we have accurate information on file.

If participants choose to violate the Code of Conduct, the participant's parent(s) or guardian(s) may be contacted by Teen Center staff and the participant will be sent home. Participants must understand that attending the South Portland Teen Center is a privilege, and that if they choose to display conduct that is inappropriate, they will lose privileges. Overall, our goal is to keep the Teen Center a safe place for all of our participants and staff.

I have read and fully understand the Conduct Code and will abide by the Teen Center rules. If I damage equipment I understand I am responsible for paying for the damaged equipment or supplies. I am aware that if I fail to abide by the rules I will be suspended from using the Teen Center.
